ELLERSLY ROAD.**

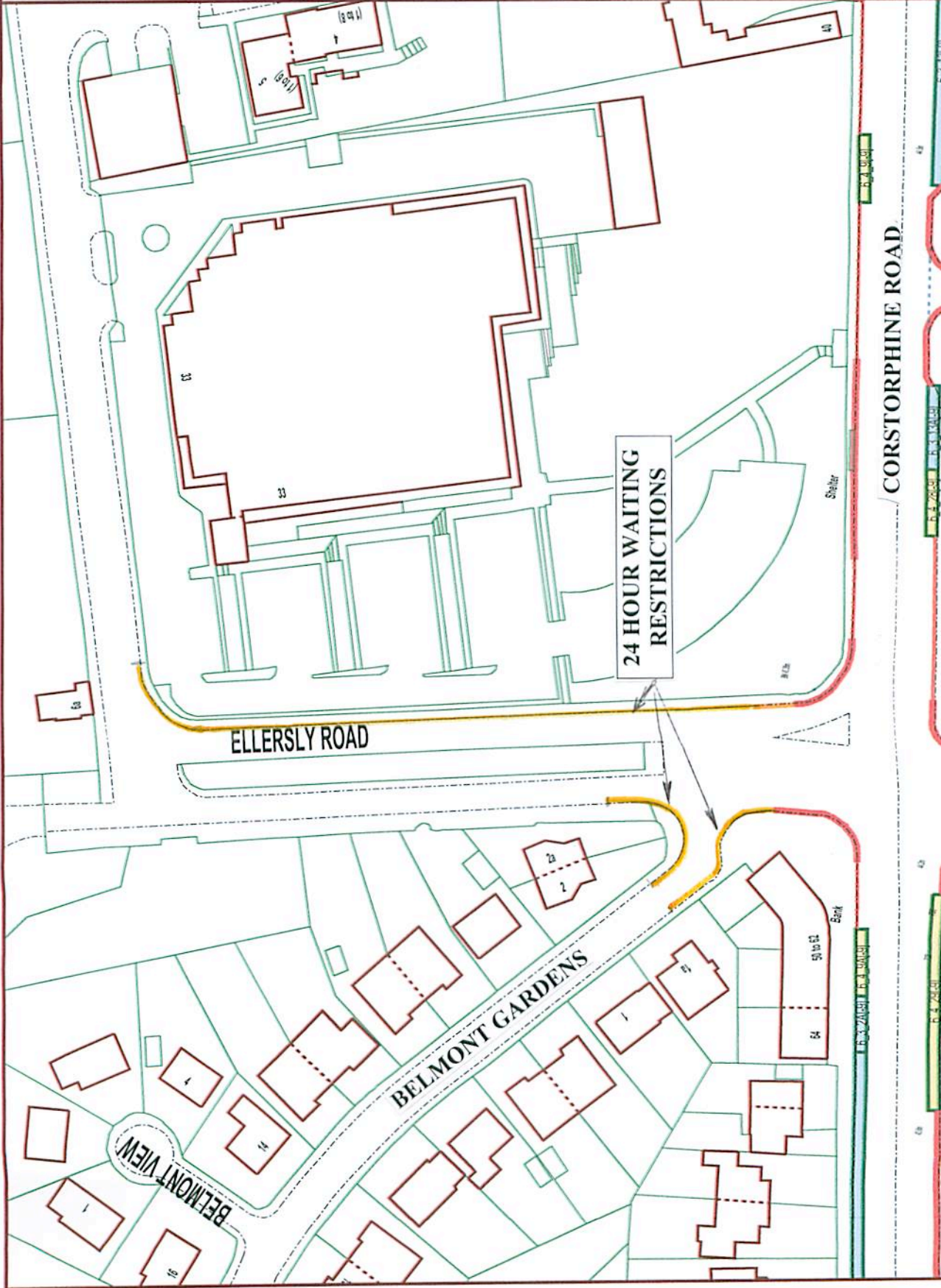
**A COPY OF THE DRAFT ORDER TOGETHER WITH (1) A MAP SHOWING THE
